For any person using the arena or marshalling area when the show is not in progress, but the show has not finished, is a minimum of long western style pants/jodhpurs, safe enclosed footwear and a shirt with sleeves. No training equipment is allowed in the marshalling area or the performance arena one (1) hour prior to the commencement of the show and one (1) hour after the cessation of the show, on each day of the show.
